## NOTIFICATION

### Project/ Thesis/Research Paper Honorarium Policy

The undersigned is pleased to notify the revised policy for payment of honorarium regarding Project/Thesis/Research Publication with effect from Fall 2019 till further communication:

#### 1. Undergrad Project

- i) Supervisor shall be paid **Rs. 12,000/-** per project up to maximum of 05 projects per semester.
- ii) For a group less than 3 students, **Rs. 3,000/-** per student shall be paid.
- iii) Payment for the supervision work shall be made on successful conclusion of the projects, submission of project report/thesis and grades.

#### 2. MS Thesis/Project

- i) Supervisor shall be paid on the completion of thesis/project as per following:-
  - a. MS Thesis - **Rs. 18,000/-**
  - b. MS Project - **Rs. 6,000/-**
- ii) MS Thesis examiner shall be paid as:-
  - a. External (one) - **Rs. 6,000/-**
  - b. Internal (one) - **Rs. 3,000/-**

#### 3. PhD Thesis

- i) Supervisor shall be paid **Rs. 100,000/-** on the successful completion of PhD dissertation.
- ii) PhD synopsis examiners shall be paid as:-
  - a. BASR Nominee (one) - **Rs. 5,000/-**
  - b. Internal (one) - **Rs. 5,000/-**

- iii) PhD dissertation examiners shall be paid as:-
  - a. External (two) - **Rs. 15,000/-** each
  - b. Internal (one) - **Rs. 7,500/-**
- iv) PhD Foreign evaluator/reviewer shall be paid as:-
  - a. Reviewer (two) - **\$350/-** each
- v) Synopsis evaluation, foreign review and PhD examination fee shall be charged from the scholar.

#### 4. Research Publication

- i) On publication of a research article, in ISI indexed journal, having non-zero Impact Factor, one author from the University shall be paid **Rs.20,000/-** provided: -
  - a. Article is published in the same calendar year in which the honorarium is claimed.
  - b. The article has been published with the University name.
  - c. For collaborative research, the principal author should be from the University.

#### 5. Repeat Examination

- i) In case of re-examination, the evaluation fee shall be charged from the student.
